## 2011 – Arizona School Tax Credit Program

Arizona School Tax Credit monies are used for Extracurricular Activities or character education programs. School tax credit monies cannot be allocated to a specific class/teacher or for a recreational event. An individual may contribute and receive a tax credit for any amount up to \$200, and a couple filing jointly may contribute up to \$400. This will result in a reduction in your Arizona state tax bill and may be used to reduce your tax liability to zero. You would use AZ Form 322 to claim this credit. Please consult your tax professional for more information regarding the Arizona School Tax Credit Program and the impact on state and federal tax preparation.
